Background Information

The Multi-Donor Action "Digitalisation of Micro and Small businesses to increase their resilience in the crisis - Digital4Business" which is jointly financed by the European Union (EU) and the German Federal Ministry for Economic Cooperation and Development (BMZ), is implemented by GIZ in the framework of the Digital Transformation Center in the Innovation and Training Park (ITP) Prizren.

The <u>Digital Transformation Center</u> aims to become an one-stop-shop for digital ecosystem development. Bridging between two of its main pillars – "Science and Education" and "Technology for Business" – it is building up offerings specifically also to strengthen industry-university-collaboration. In this context, the Action supports partnerships between Higher Education Institutions (HEI) and micro and small, but also medium sized businesses (MSMB)¹ by financing 4 projects in applied research.

Grant Objectives and Scope

The Action is seeking applications from public Higher Education Institutions (HEI) in Kosovo for applied research proposals in consortium with at least one MSMB in Kosovo. The applicant (a public HEI) is considered the lead institution, whereas other HEI (public or private) and business partners are considered partners. We highly encourage engagement of research teams consisting of lead researcher, research team, and research/project support staff. We encourage applications to include master or PhD students in their research teams.

The call is open to all research areas with a condition to cooperate with at least one business partner. Collaborations between specific research teams from more than one university are allowed, with one of the public universities being the grantee or implementing institution.

Applied research project proposals require a collaboration model that is beneficial for both HEI and businesses. The proposals may address one of the following models:

- 1. A proposal addressing a research need for business scale-up requiring scholarly surveys, market research, product development, internal analysis/change/innovation, thus offering a specific development gain for the business.
- 2. A proposal involving a collaboration between a research team and business where a scholarly or business research topic needs a combination of specific knowledge and laboratory equipment.
- 3. A proposal involving a collaboration between a HEI and an enterprise to solve a concrete community problem.
- 4. A proposal involving a business partner that requires to address a significant problem that requires research-based approach.

5. Proposals that address business needs with large data sets but with no digital infrastructure for scientific data management, statistical analysis and interpretation.

Grant Award Modalities and Time Frame:

The call will be open from 15/09/2022 till 01/12/2022.

During this time there will be training sessions for representatives of HEI and businesses, as well as individual researchers to help them structure the university and business partnership models and work on their applied research ideas. An information for the training sessions will be given in time. They are planned to start in October 2022.

GIZ will award four grants in the amount of up to 50,000 euros.

If a project consists of permanently increasing the ITP Prizren's capacities (e.g. by renting space for a lab), other benefits can apply on individual basis (like coverage of renovation costs as per demand by the partners).

The anticipated period of the implementation of the projects is one year. The estimated start date is 1 February 2023 until 31 January 2024.

Cost Share is desirable and strongly encouraged in order to contribute to HEI and business commitment to applied research activities. However, it is not mandatory.

Selection of applications and grant award management

The selection committee established by GIZ will evaluate the received project proposals. Applicants will receive a written response by the end of December 2022

Annex A

Legal personality

- What is the legal form of the potential recipient?
